



## Bi-annual Personal Interest Summary

March 2025

Initial and Bi-annual Personal Interest Returns are records of the private interest of a person in public office that assists in improving transparency and reducing conflicts of interest. It is a requirement under Sections 133 and 134 of the *Local Government Act 2020* that specified persons lodge an Initial Personal Interest Return on commencement of their role or appointment as a Nominated Officer and, a Bi-annual Personal Interest Return every 6 months with the Chief Executive Officer (CEO). A specified person that is required to complete a personal interest return is the CEO, Councillors and Officers nominated by the CEO if they have a statutory or delegated power, duty or function.

Section 8 of the the *Local Government (Governance and Integrity) Regulations 2024* (the Regulations 2024), details the information that is to be disclosed in each return.
